Advancing Circular Economy in Mexico through collaborative efforts between AUSMEX Circular Economy Hub and the Education Sector

The transition to a Circular Economy (CE) is a global imperative, and universities are at the forefront of leading this transformative change. However, challenges persist in understanding the CE concept and, more importantly, translating it into practical applications. The University of Sydney (USYD) is leading the way internationally in the Circular Economy, spearheading initiatives such as the Waste Transformation Research Hub (WTRH) to build capacity and capabilities in Circular Economy in collaboration with government and industry partners.

This presentation aims to explore the pivotal role of research institutions in developing cooperation models crucial for the realising Circular Economy technology and policy translations. Specifically, the focus will be on the Circular Economy Clean Tech Hub (CECTH), which aims to provide targeted place-based training for both university students and industry professionals. Its objective is to advance circular and clean technologies, while simultaneously stimulating regional economies facing skill shortages. This presentation will also highlight the transformative impact of collaborations within the Water theme of the WTRH at the USYD, focusing on the crucial role of international higher education. Additionally, the presentation will explore the broader implications of these partnerships for international education, including opportunities for cross-border collaboration, knowledge sharing, and the development of global competencies.

Furthermore, the presentation will focus on the collaborative efforts between USYD's WTRH, the AUSMEX Circular Economy Hub and the education sector in Mexico, highlighting programs and initiatives aimed at fostering circular economy practices. The AUSMEX Circular Economy Hub is a non-governmental nonprofit organization that promotes and implements the principles of circular economy through a Mexico-Australia relationship.

The AUSMEX Circular Economy Hub engages relevant stakeholders from industry, government, and academia to promote and implement circular economy principles. One of its key initiatives is the establishment of a local satellite laboratory of USYD's WTRH, providing a platform for local organisations and research centres in Mexico to develop and test technology related to circular economy practices.

The AUSMEX CE Hub has already established collaborations with several entities such as IPA (CAINTRA), the Institute of Innovation and Technology Transfer (I2T2), the Ministry of Economy of Nuevo León, INEEL, CIATEC, Tec de Monterrey, GreenTech, and Prodivant. The Hub aims to further engage universities in Nuevo León, the State Congress, Industrial Parks, citizens, state and municipal governments, enterprises of all sizes, and non-governmental organisations, inviting them to collaborate through the creation of the Nuevo León Circular Council, the Circular Business Linkage Network, individual interactions, project invitations, private consultations, masterclasses, workshops, and micro-credentials.

This presentation demonstrates the crucial role of collaborations between the WTRH, the AUSMEX Circular Economy Hub and the education sector in Mexico in promoting circular economy practices, fostering sustainable development, and accelerating the transition towards a more resource-efficient and resilient future.

Australia and Mexico have much to offer each other as international education partners, across different fields of knowledge and a range of shared strategic interests.
